Motion by Burns to amend the 2009-2010 budget Fund 101 General Fund as follows: Increase Transfer in 101-000-676 by \$21,000.00 which changes total revenues from \$475,200.00 to \$496,200.00. Increase Capital Outlay Roads 101-224-970 by \$21,000.00 which changes the total in Roads from \$5,000.00 to \$26,000.00. Supported by Mead. Voice Vote: All ayes. Motion carried.
