(A) Committee reports were received.

Building & Grounds:

Burns reported that she is seeking estimates for a new roof on the Township Hall. Also reported that a new furnace has been ordered for the Fire Hall, and the furnace will be installed on Friday by Moore Mechanical.

Fire Department:

Request by the Fire Chief to purchase Ice & Water Rescue Equipment.

Motion by Barnard to purchase the gear for the Ice & Water Rescue up to \$6,000. Supported by Priest. Roll Call Vote: Sheets, yes. Heller, yes. Priest, yes. Barnard, yes. Burns, yes. Motion carried.

NEW BUSINESS:

I. Discussion Fireworks Ordinance

Supervisor reported on his response from MTA regarding pending legislation on it.

2. Brad Schaub - Benzie Co. Rd. Comm. - Storm Sewer Project

Brad presented Sketch #l for a storm sewer project on Cedar St. – at a cost to the Township of \$3,500.

Presented Sketch #2 for a storm sewer project on Bixler Rd. at a cost of \$5,000 to the Township.

Discussion followed.

*Supervisor recommended authorizing to spend not more than \$9,000 for the two projects.

Motion by Burns to go forward with the Cedar St. and Bixler Rd. projects for a total not to exceed \$9,000 from the 2015-2016 budget. Supported by Barnard. Roll Call Vote: Burns, yes. Barnard, yes. Heller, yes. Priest, yes. Sheets, yes. Motion carried.

3. Christy Brow, Assessor - Full Tribunal Appeals - Dean Michaels & Watson.

Assessor not present. *Burns explained about the process for the Tribunal Appeals and the Township stipulating to them. Discussion. *Supervisor will discuss this with the County Administrator, and the board will address it at a special meeting.

4. Frank Post - Hazardous Mitigation Plan

Presented a draft plan of the Hazardous Mitigation Plan – asking the board to review and adopt a resolution for it at their next meeting. He also presented a sample recolution guide for the Clerk to use.

EXTENDED PUBLIC COMMENT:

Superivsor acknowledged the two high school students in attendance.

Fire Chief suggested that the Township Board send a letter to the Board of Commissioners in opposition to the Sheriff's Dept. taking over the dispatch service, and also the Emergency Manager.

Supervisor adjourned the meeting at 9:05 p.m.
