REGULAR MEETING, June 14, 2017 Meeting called to order by Supervisor Barnard at 7:30pm.

All surveillance signs have been installed at the park. A new tire swing will be bought to replace the old one this week. People have been driving through the lawn and soccer fields, so discussion on installing a rope fence to deter it from happening. Ken got an estimate of \$1,630 from Honor Building Supply. Burns made a motion to put a fence in as discussed, not to exceed \$2,500, supported by Sheets.
