- c) Not more than 3 provisioning centers, with 2 being in commercial zoning and 1 in industrial zoning
- d) Not more than 2 Safety compliance centers with 1 being in industrial and 1 being in commercial zoning
- e) Not more than 2 secure transporters in industrial and commercial zoning
- f) There are no fees associated with it as of yet

Motion by Sheets to adopt the ordinance providing the ordinance to authorize that Benzonia Township opts in for the process of establishing Medical Marijuana facilities, supported by Priest. A roll call vote was taken as follows: Burns, yes; Sheets, yes; Heller, yes; Barnard, yes; Priest, yes. All Ayes, Motion carried.
