- Burns made a motion to ament the 2018-2019 Road Improvement Fund as follows:
- Transfer \$17,000.00 to transfer out 245-986 thereby increasing that balance to \$33,000.00 and reducing Contingency to \$137,500.00 Sheets supported. Roll call vote: Sheets yes, Burns yes, Barnard yes, Heller yes, Priest yes. Motion passed.
